



PLAY PROJECT CONSULTANT RECERTIFICATION POLICY

Introduction

The purpose of PLAY Project re-certification is to ensure that Certified PLAY Project Consultants (PPC) continue to 1) deliver this evidence-based model with fidelity, 2) hone their therapeutic and educational practice, and 3) stay up-to-date with the most current research and best practices in the field of developmental autism services.

Application Process

The recertification application is a simple online form based on the PPC's own documentation of their work. PLAY Project HQ reserves the right to audit any re-certification application. [You can submit by clicking here.](#)

Timeframe: The first recertification occurs approximately 3 years after the PPC's initial certification (i.e. after PPC has completed all supervision tasks and has received their official PLAY Project Consultant Certificate). Recertification then occurs on a 3-year cycle. Over each 3-year period, the professional must complete a minimum of 3 hours per year of combined professional education & PLAY Project presentations.

Application Review: Applications will be reviewed biannually in January and July, based on the date of initial certification.

- **Example:** a PPC who earns initial certification in April of 2017 will have until July 2020 to earn and report the necessary number of points for recertification. A PPC who earns initial certification in August 2017 will have until January 2021 to earn and report the necessary number of points for recertification.

Fees: There is no additional fee for re-certification if a PPC meets their 3-year deadline. The PLAY Project annual licensing fee includes this service.

Lapse in Certification Status

If a PPC does not apply for re-certification by their deadline, they may apply within 6 months of that deadline and a \$100 fee will be charged for processing the application. If re-certification is not achieved within 6 months of the deadline, the PPC's license will be discontinued. See our "Re-Activation Policy" for additional information.

Re-Certification Requirements

The PPC must complete a minimum of 3 hours per year of PLAY Project professional development & presentations. Unless specifically outlined below, no additional documentation is required for self-reporting of activities, but the PPC should keep records for accurate reporting. PPHQ reserves the right to ask for additional documentation as needed.

1. **PLAY Project Services: Minimum of 5 PLAY Project or Teaching PLAY clients over the 3 year period.**

- **PLAY Project clients:** If fewer than 5 PLAY Project clients are seen over the 3 year period, watch short case study videos and upload a complete VRF on each case. Videos can be found in the 'Re-Certification' folder in Sharefile.
- **Documentation:**
 - Upload one Video Review report dated within the past 3 years, last names blacked out.
 - Upload current resume or bio
 - Report approximate estimation of number of cases over the past 3 years

2. **PLAY Project Professional Development: Minimum of 3 hours/per year of combined PLAY Project education & presentations**

- **Attend a Webinar** (4 free webinars offered annually with active license)
 - Live attendance or review of recorded session acceptable
- **Provide a community presentation of the PLAY Project** (power point templates available in Sharefile):
 - An hour-long community presentation
- **Participate in a PLAY Project online course** (discounted rates available) Hours vary by course
- **Participate in a PLAY Project In-person workshop or training:** Hours vary by training.
- **Documentation:**
 - Report number of webinars attended
 - Report community presentation dates, audience population, and approximate size of audience
 - Report names of PLAY online courses and date of completion
 - Report names and dates of PLAY Project workshops/trainings attended
