



PLAY Supervision Process

Supervision Process

12 required Supervision tasks. These may be completed in any order with the exception that the final task must be to submit a final online case submission to TD.

- 4 Online Case Submissions
- 5 Individual Mentoring Sessions
- 1 Group Case Presentation (as Presenter)
- 2 Group Case Presentations (as Attendee)

You will track your progress on your Supervision Tracking Sheet (provided at the start of Supervision) and submit to the Training Director upon completion of the 12 Supervision tasks.

Please note that it is strongly recommended that you begin with an Online Case Submission as your first task.

Baseline video (FEAS) guidance:

Submitting a Baseline video (FEAS) is optional, but recommended for your first submission. These videos are a baseline video of the caregivers playing with the child without coaching or modeling by the PPC. You may submit up to 2 Baseline (FEAS) videos:

- 1 Baseline video (FEAS) for 1st Online Case Submission
- 1 Baseline video (FEAS) for 1st Individual Mentoring Session

Dual (PP and TP) Certification guidance:

For Consultants who are pursuing Dual Certification (both PLAY and Teaching PLAY Certification) you must submit at least 3 tasks that are Teaching PLAY Cases. You may not use Group Case Presentation Attendee tasks towards these 3 required tasks.

4 Online Case submissions

- Total of 4 Online Case Submissions completed
- Assigned 3 supervisors on your Supervision Tracking Sheet. Final task (#12) will be submitted to Training Director
- Coaching and Modeling Videos, Video Review Form ([Narrative](#) or [Automated](#)), [Visit Suggestion Report](#).
 - Your 1st submission may be a baseline (FEAS) video
- All are uploaded to ShareFile (<https://playproject.sharefile.com>) into your individual training folder
- Complete Case Submission Form (www.playproject.org/supervision). This will notify supervisor to review
- Supervisor will review and provide audiofeedback for you to listen to and apply feedback to your work with families and classrooms
- Supervisor will complete the scoring form, which will be emailed to you after audiofeedback is completed.

5 Individual Mentoring Sessions

- 5 Individual Mentoring Sessions required
- 1:1 live 1 hour session with Lead Supervisor via Zoom
 - Note: may be recorded for training purposes
 - Trainee must have camera ON during session
- Schedule Individual Mentoring Session at this link:

 - You may choose a specific Lead Supervisor OR choose a slot based upon availability
- 12-15 minutes of Coaching and Modeling videos, [PLAY Plan](#) (No video review section) and Visit Suggestion Report
 - You will submit PLAY Plan and Visit Suggestion Report ahead of time (at least 24 hours in advance) to Supervisor
 - You may email directly to the Lead Supervisor or upload into your ShareFile training folder for the Lead Supervisor to access
 - You will share videos from your screen during the Zoom session
 - It is HIGHLY recommended to have your videos uploaded with a link available to share with the Supervisor in case of internet /screen sharing issues or upload into your ShareFile training folder
 - Your 1st session may be a baseline (FEAS) video
- Reflective process. Use this session to ask questions about PLAY implementation in your setting, the training process, family dynamics and to discuss any barriers you may be experiencing
- Complete [Post-Session Review Form](#). Link will be emailed to you right afterwards
 - You MUST complete this form to receive "credit" for the task
- Lead Supervisors will complete a scoring form which will be emailed to you after the session.

1 Group Case Presentation (As Presenter):

- 1 Group Case Presentation required
- Group Meeting via Zoom. 1 trainee presents a case, up to 6 additional trainee attendees to participate in discussion
 - Note: may be recorded for training purposes
 - Trainees must have camera ON during session
- Schedule Group Case Presentation (As Presenter) at this link:

 - You must select a Lead Supervisor when scheduling
 - Presenters must be the first person to sign up for a Group Case Presentation, showing 7 available slots on the calendar. Once Presenters have signed up, additional trainees may sign-up as an attendee
- 12-15 minutes of Coaching and Modeling Videos. No other documents required.
 - You will share videos from your screen during the Zoom session
 - It is HIGHLY recommended to have your videos uploaded with a link available to share with the Supervisor in case of Internet /screen sharing issues or upload into your ShareFile training folder

- Be prepared to discuss child background information: age of the child, family has been involved in PLAY, any relevant family dynamics, etc.
- You should prepare a PLAY Plan ahead of time to be ready to discuss this case, however, you do not have to share the PLAY Plan with the Lead Supervisor or group attendees.
- Complete [Post-Session Review Form](#). Link will be emailed to you right afterwards
 - You MUST complete this form to receive "credit" for the task
- The Lead Supervisor will submit a Group Case Presentation Feedback Form that will be sent directly to the Presenter.

2 Group Case Presentations (As Attendee):

- 2 Group Case Presentations Attendee required.
- Group Meeting via Zoom. 1 trainee presents a case, up to 6 additional trainee attendees to participate in discussion
 - Note: may be recorded for training purposes
 - Trainees must have camera ON during session
- Schedule Group Case Presentation (As Presenter) at this link: <https://playproject.org/supervisorscheduling/>
 - All scheduled Group Case Presentations will be listed on the scheduling page
 - You must select a Lead Supervisor when scheduling
 - Attendees must schedule in slots where a Presenter has already signed-up. This means that the schedule slot will show 6 or less spots remaining.
- Attendees are expected to actively participate. Review videos, ask questions, offer support/guidance to the Presenter.
- Complete [Post-Session Review Form](#). Link will be emailed to you right afterwards
 - You MUST complete this form to receive "credit" for the task
- Lead Supervisor will submit Group Case Presentation Attendance list to confirm attendance and participation
